Appeals to the Chief Engineer.

A. Any applicant contesting permit conditions, a written notice of permit denial by the Floodplain Administrator, or a boundary determination of a regulatory floodplain, floodway, erosion hazard area, or riparian habitat shall first request a formal review by the Chief Engineer on a form approved by the District within 30 business days from receipt of the written notice.

B. Within 10 business days of receipt of the written review request form, the Chief Engineer may:

1. Meet with the applicant; or
2. Request, in writing, such additional information as is deemed necessary in order to render a written finding.

C. The Chief Engineer shall issue a written finding not more than 45 business days following the receipt of all required information.
