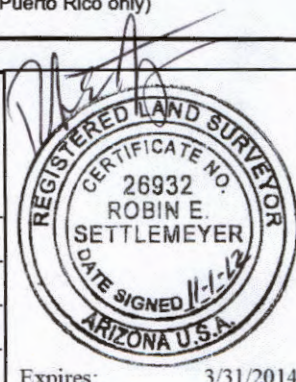

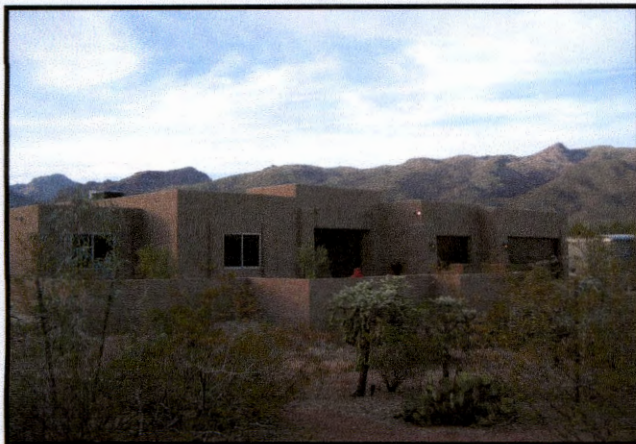

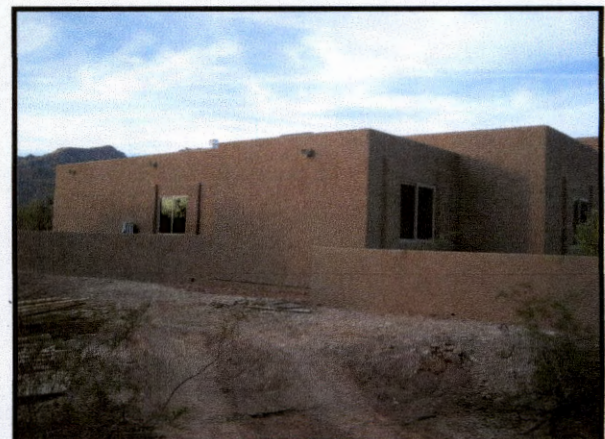
Side View (viewed looking southwest)
