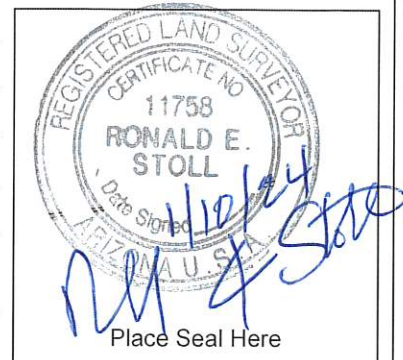

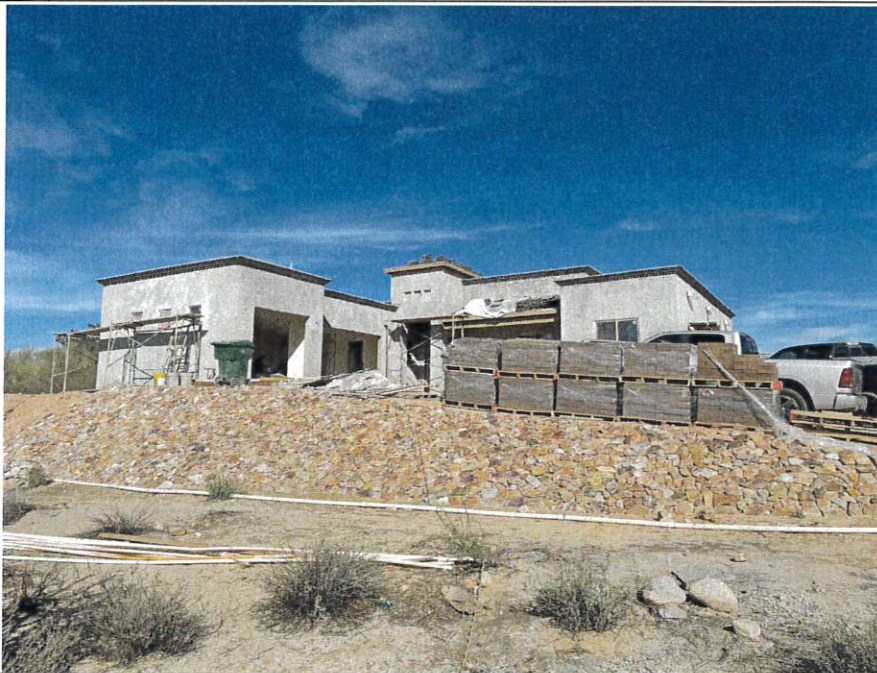


Photo One Caption: SOUTH SIDE
