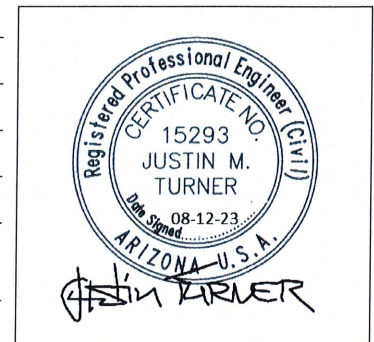

Attachments: Four photographs of each side of the building showing a replacement manufactured home elevated on jack stands (hidden from view) and a block masonry (CMU) skirt with flow-through openings consisting of 28 concrete-masonry units mounted sideways (55 square inches of open area each). Two 30-inch wide man ways are also visible in these photographs, and only the bottom one foot of the east man way counts towards the minimum required vent area, as the west man way is too high above grade. The foundation of the flood-vented CMU stem wall is protected from erosion by a footing that is at least 30 inches below natural grade along the upsream edge and within 10 feet of the upstream corners, and at least 18 inches below natural grade for the remainder of the structure as further described on Sheet 9 of 10 of the State of Arizona Office of Manufactured Housing "Minimum Standards for Manufactured Housing Foundations in Shallow Sheet Flooding Area" dated February 1, 2021. The foundation and footing passed inspection by the Arizona Department of Housing on May 24, 2023.
