He said looks like flood venting on the northeast side of the smaller barn (called steer barn on the site plan) can bring the structure into conformance. Since the south facing side of the steer barn is open sided. Regarding the bigger barn (called livestock barn on the site plan), there are three enclosed rooms inside. Although the obstructing length of the enclosed rooms is less than 40 ft, it is not parallel to the flow. Therefore, Andy wants to see an engineer analysis for that to make sure the foundation is protected from scour. Regarding the arena. Andy mentioned, grading the proposed area may divert the historical flow and drainage that already exists and adversely impact the neighbors. He wants to see an engineering design to address the new drainage and analysis. Looks like existing fence was place before Lee Moore Wash study effective date in 2019. 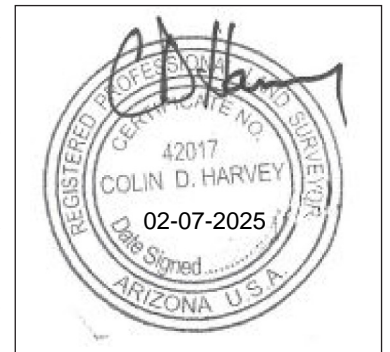
