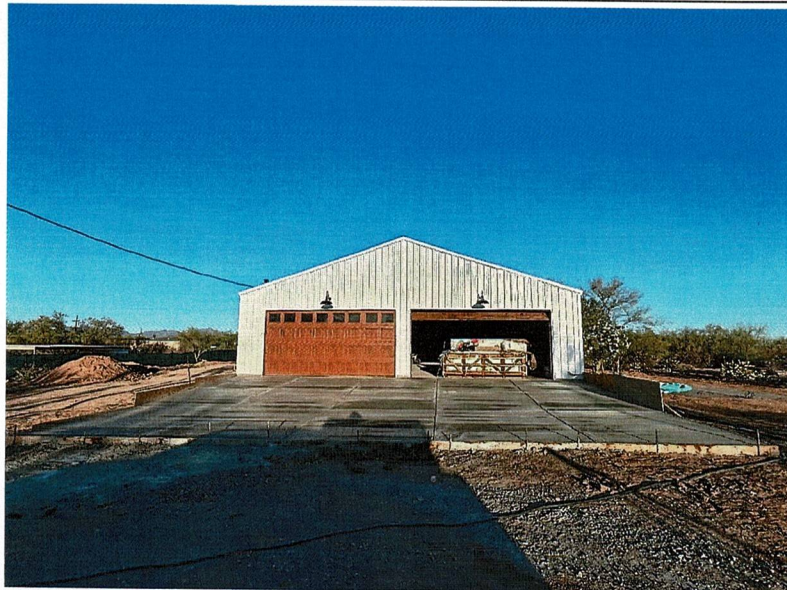

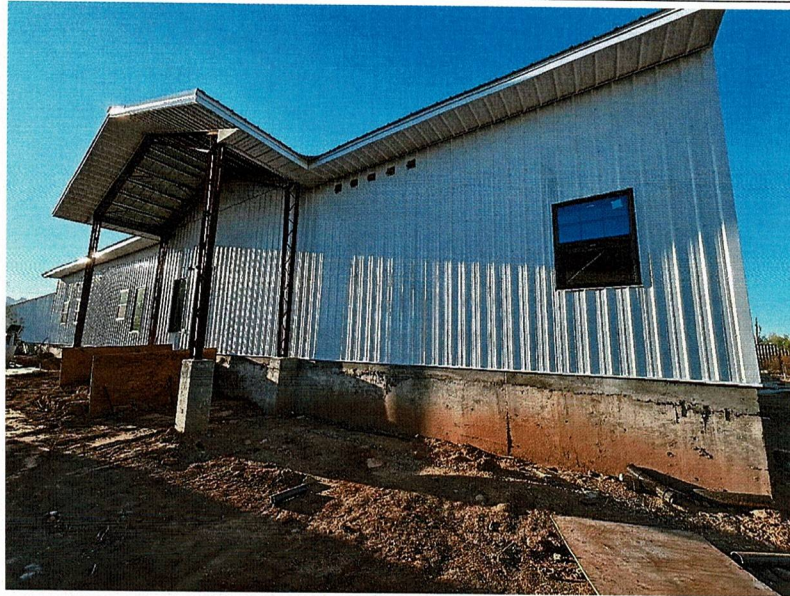

Photo Three Caption: REAR VIEW

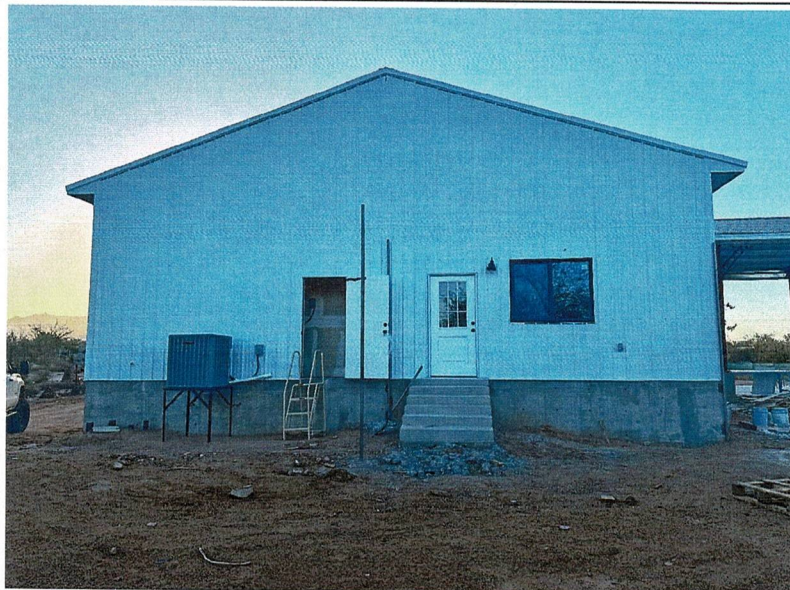
