The lowest service equipment (C2.e) is the AC compressor. Highest adjacent natural grade (HANG) is 2717.6 @ 0.5 BFE per Bruce Paton PE. FloodPlain/Depth of Fill Exhibit (Dated 12/12/22). Lowest adjacent natural grade (LANG) is 2717.3. Elevation of (C2.d) is end of top of garage floor and not the drop of the door seal. The basis of elevation (BOE) is per the approved grading plan for Sahuarita Acres. The highest and lowest adjacent natural grade was determined from topographic mapping and data terrain models created from Sun Mapping LLC dated 04/09/17. HANG (B11) to BOE conversion 100.0 = 2717.6, HAG=2719.1 LAG=2718.5.
