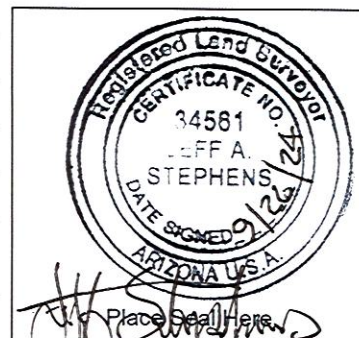

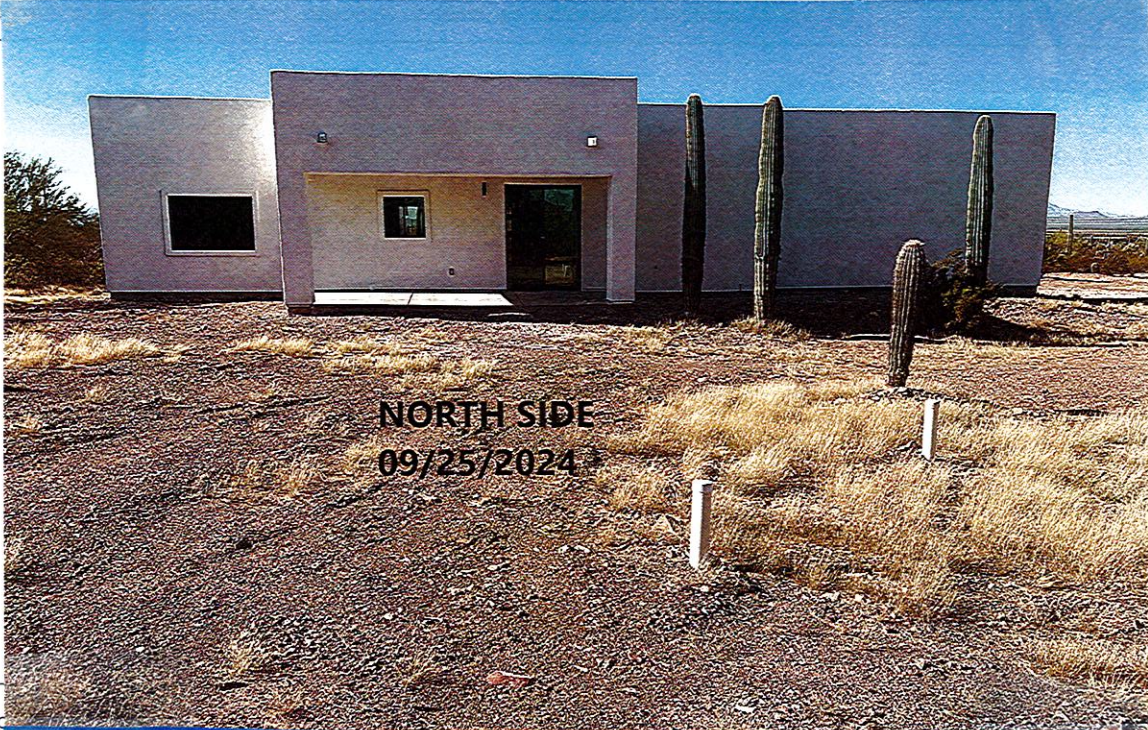


Photo One Call

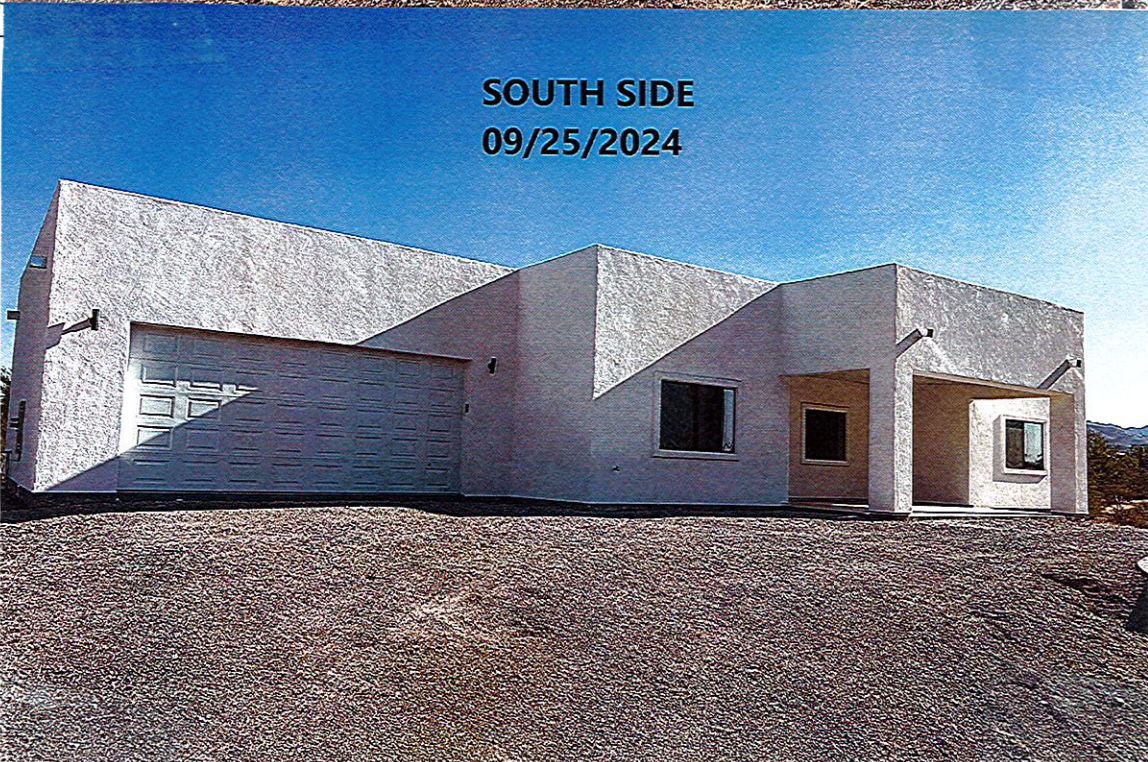
