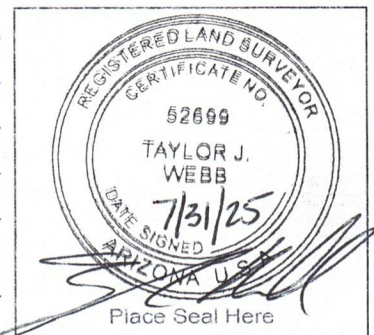

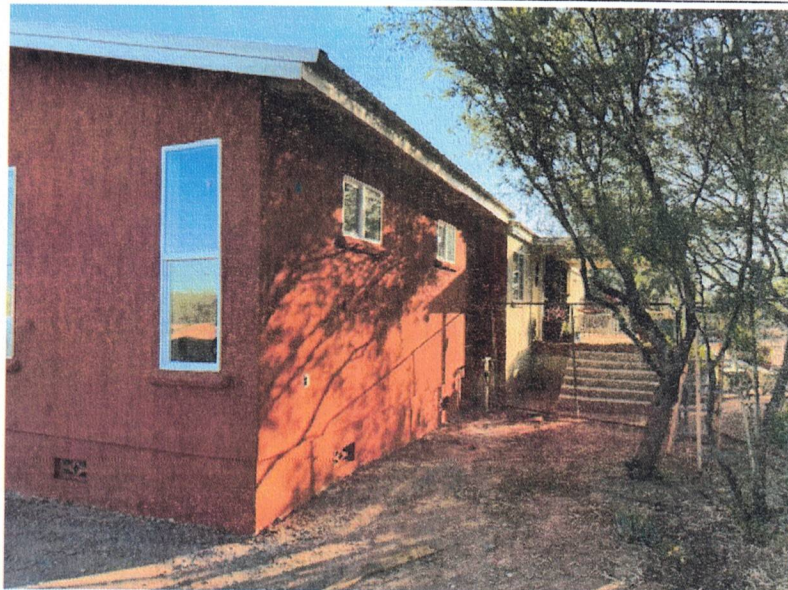

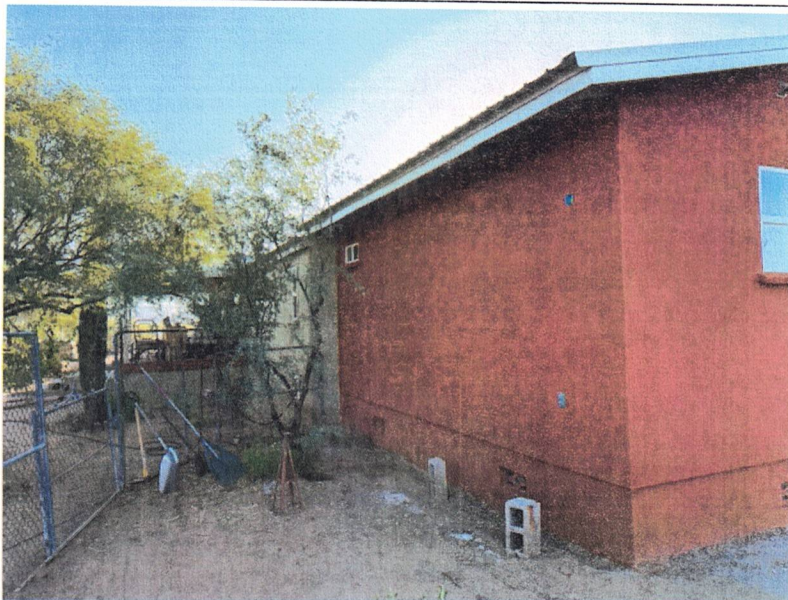

Photo Three Caption: West Side 7/29/25

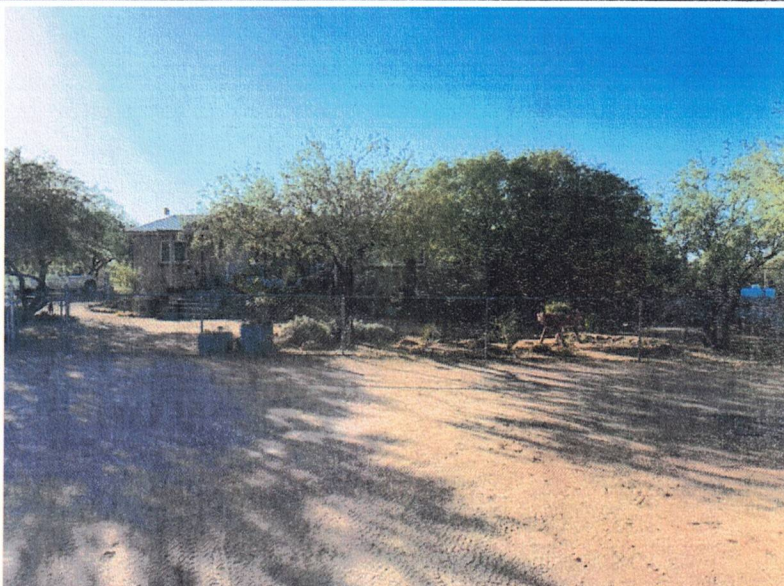
