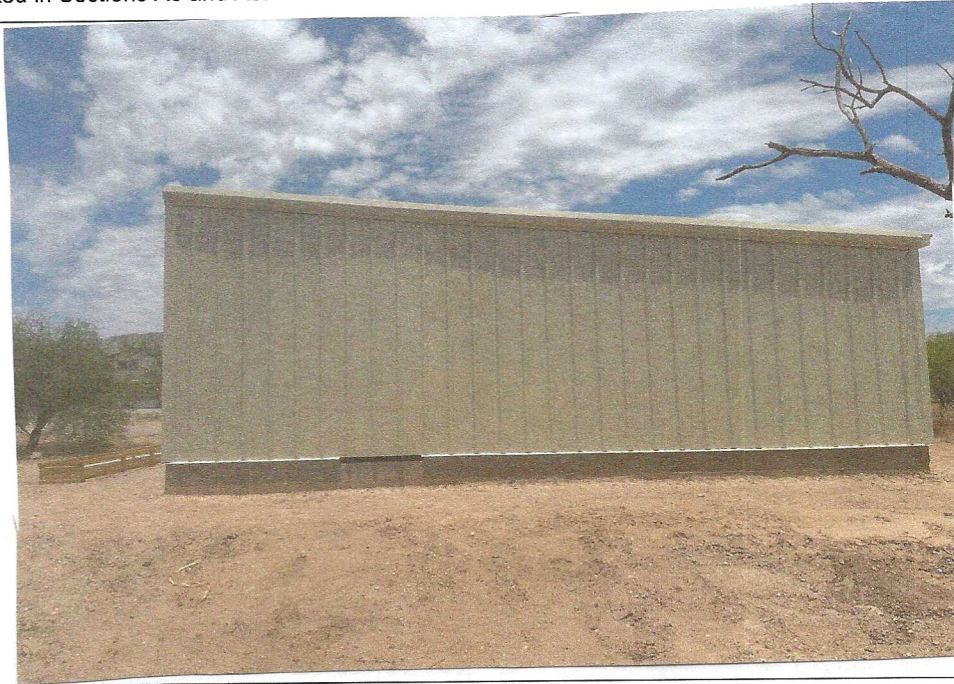


Photo Three Caption: SOUTH SIDE, REAR, DOWNSTREAM 6-30-25

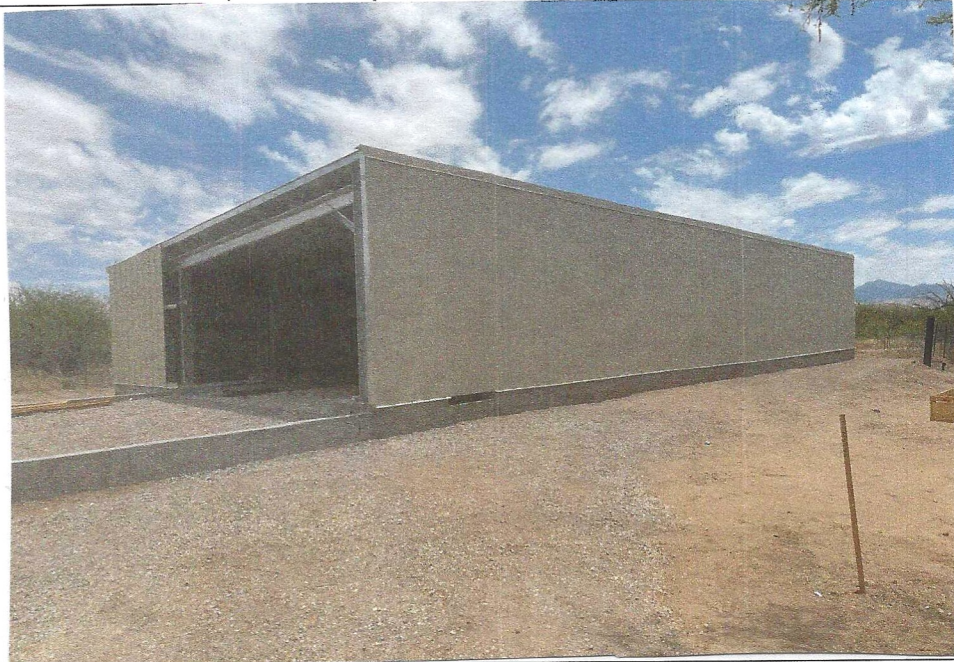


Photo Four Caption: WESTSIDE, RIGHT 6-30-25
