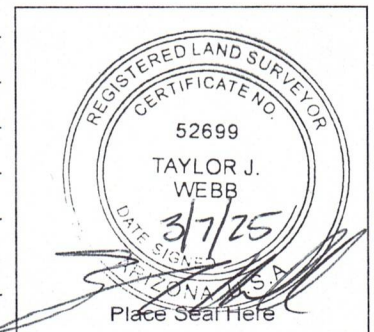

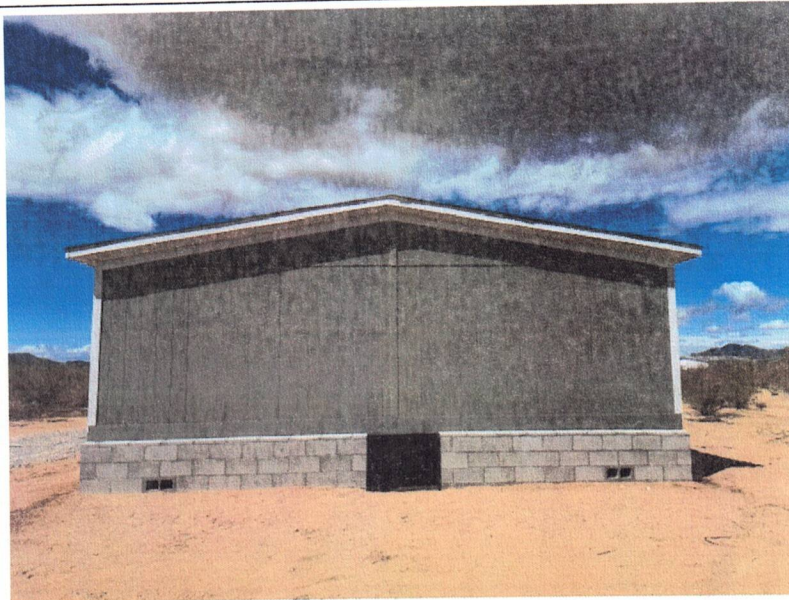

Photo One Caption: East Side 3/7/25

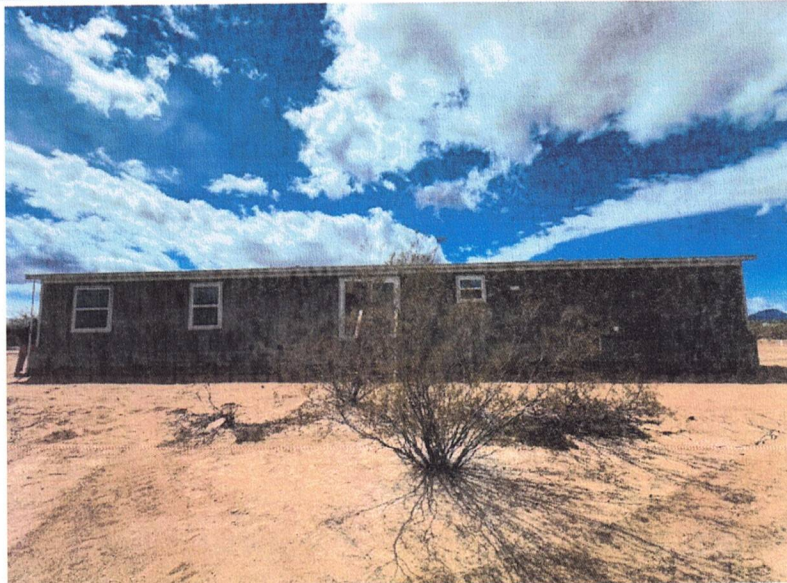
