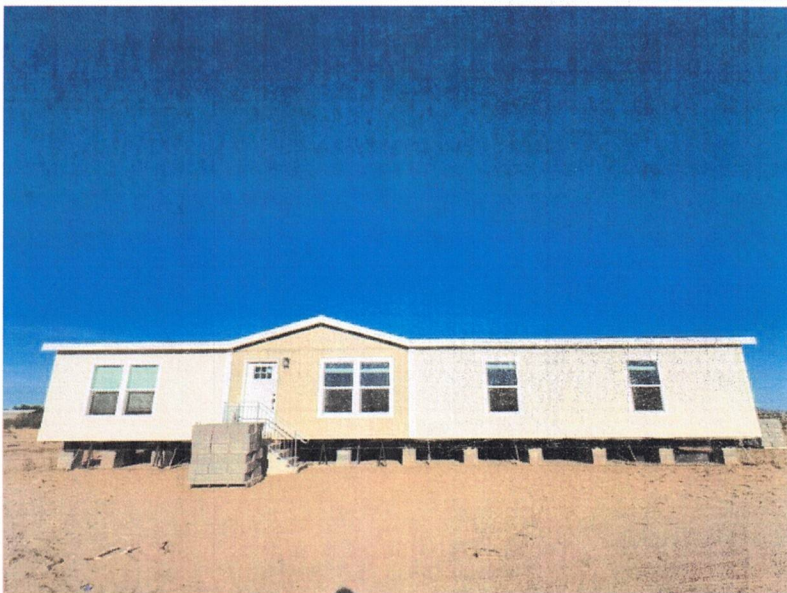

Photo One Caption: East Side 5/12/26

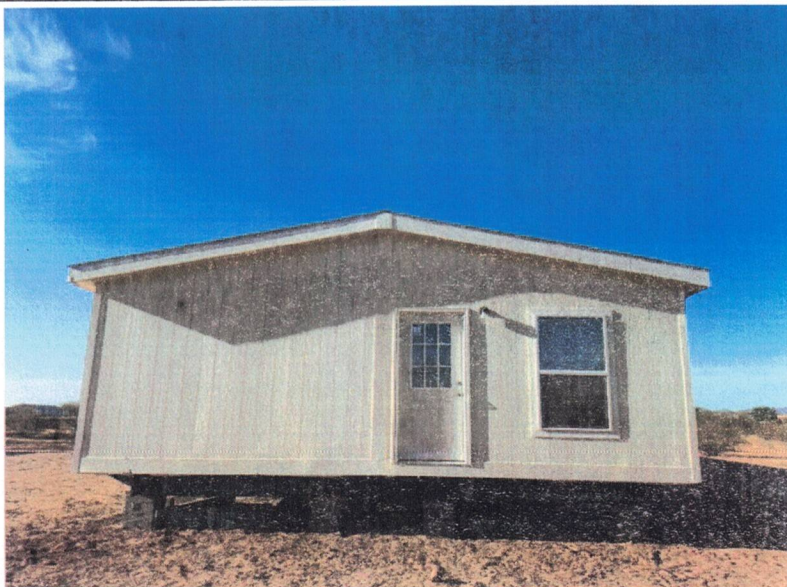

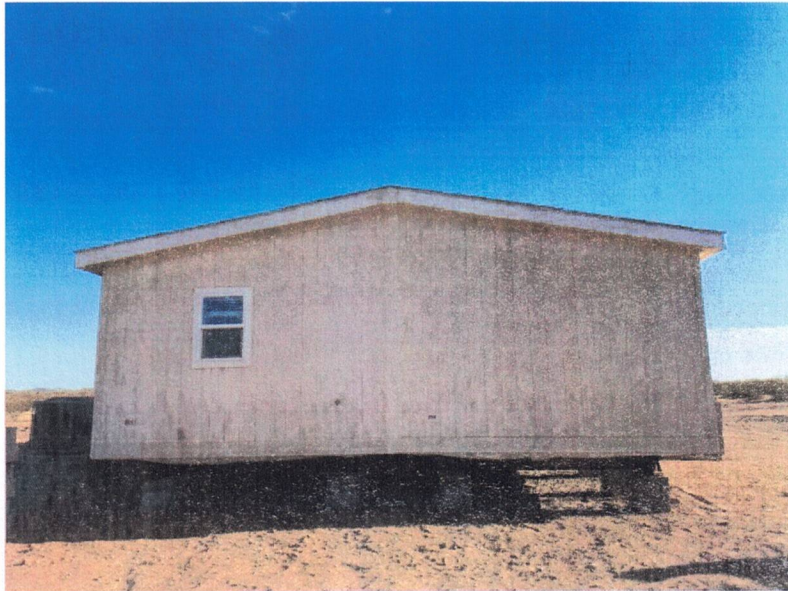

Photo Three Caption: South Side 5/12/26

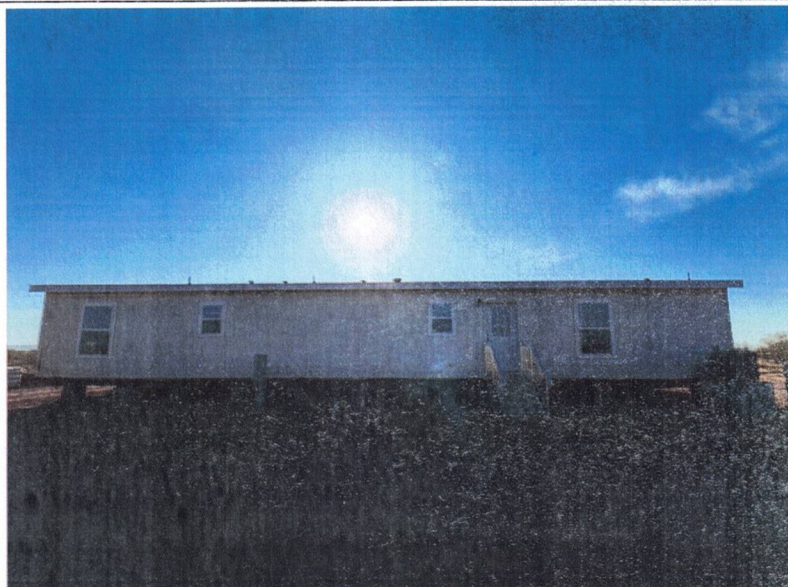
