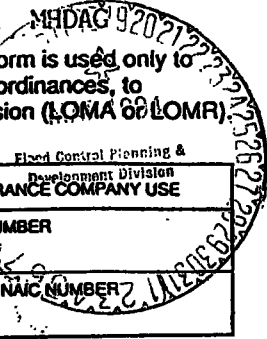

ATTENTION: Use of this certificate does not provide a waiver of the flood insurance purchase requirement. This form is used only to provide elevation information necessary to ensure compliance with applicable community floodplain management ordinances, to determine the proper insurance premium rate, and/or to support a request for a Letter of Map Amendment or Revision (LOMA or LOMR). SECTION E CERTIFICATION

This certification is to be signed by a land surveyor, engineer, or architect who is authorized by state or local law to certify elevation information when the elevation information for Zones A1-A30, AE, AH, A (with BFE), V1-V30, VE, and V (with BFE) is required. Community officials who are authorized by local law or ordinance to provide floodplain management information, may also sign the certification. In the case of Zones AO and A (without a FEMA or community issued BFE), a building official, a property owner, or an owner's representative may also sign the certification.

Reference level diagrams 6, 7 and 8 - Distinguishing Features-If the certifier is unable to certify to breakaway/non-breakaway wall, enclosure size, location of servicing equipment, area use, wall openings, or unfinished area Feature(s), then list the Feature(s) not included in the certification under Comments below. The diagram, number, Section C, Item 1, must still be entered.

COMMENTS: Pima County Floodplain and Erosion Hazard Management Ordinance 1988-FC2 in Article X requires the bottom of the structural frame of a manufactured home to be a minimum of one foot above the base flood elevation. For "A" or "AO" Zones Pima County requires the manufactured home floor reference level to be a minimum of one and one half feet above the bottom of the structural frame elevation which equals two and one half feet above the base flood elevation as listed in item 6 of Section B of this form. This elevation certificate is to be certified in Section E. A copy is to be returned within seven days of placement of the manufactured home, to Pima County Floodplain Management Section, 201 N.
