

Pima County Floodplain and Erosion Hazard Management Ordinance requires in Article XI that the bottom of the structural frame for a manufactured home or building be a minimum of one foot above the base flood elevation listed in item 6 of Section B of this form. The top of the referenced floor, based on actual construction is to be a minimum of two and one half (2-1/2) feet above the base flood elevation. The top of the referenced floor elevation based on actual construction is to be entered at item 2(a) of Section C of this form. This elevation certificate is to be certified in Section E.
