Letter to all Engineers:

The National Flood Insurance Program requires that the Regional Flood Control District review proposed development to assure that all necessary permits have been received from those governmental agencies from which approval is required by Federal or State Law including Section 404 of the Federal Water Pollution Control Act Amendments of 1972, 33 USC 1334 (44 CFR Section 60.3)

In order to satisfy this Federal law, the Pima County Regional Flood Control District (RFCD) requires a 404 Compliance Statement Form (four options, copies attached) be submitted as part of the first hydrology report submittal on all new developments.

The 404 Compliance Statement Form is to be signed and sealed by the professional engineer responsible for the preparation of the hydrology report. Hydrology reports lacking a 404 Compliance Statement will not be approved. For your convenience the RFCD has recently placed downloadable forms on the District website at <u>http://www.rfcd.pima.gov</u>, click on the "what's new" link.

Please advise your drainage staff that regardless of project location, <u>all</u> Drainage Reports, Drainage Statements, and Hydrology/Hydraulic Reports/Studies must include a 404 Compliance Statement sealed by an Arizona Registered Professional Civil Engineer.
